We aim above all to provide products and services complying with the current standards, contractual requirements and employment requirements, with economic analyses as competitive as possible. Antincendi Unidet carries out its activities in the utmost transparency and ethics, with moral integrity and correctness, pursuing the statutory purposes in compliance with the mission of the Company, as defined by the Code of Ethics available on the company website [www.unidet.eu](http://www.unidet.eu).

To achieve the objectives our Management has decided to adopt a **Company Quality Management System** in accordance with the standard and in order to meet its requirements, the criteria of such guidelines have been taken into account. Our components for firefighting systems comply with the norm **PED 2014/68/EU** where applicable and **Regulation EU 305/11**, where applicable, according to the norm EN 12094 and they are manufactured in accordance with the same norm; The compliance is extended to the **T-PED 2010/35/EU** norm according to the following norms: UNI EN ISO 10297, UNI EN ISO 17871, UNI EN ISO 14246.

At the end of the year 2020, we achieved the **SIL2** certification. The products covered by this certification are pressure switches ATEX and electric actuators ATEX.

An important goal has been the certification for **protection caps and (EN11117) ring nuts**, achieved at the end of 2021. At the end of the year 2022, we obtained the **flexible fittings** for gas extinguishing systems certification (**code MK.3-8**) and in 2023, the certification of the **lock-out valves – code OACL4R (0068-CPR-138/2019)**.

We operate in compliance with the law of **Privacy** and in compliance with the mandatory rules on **Health and Safety of workers** and **Social Business Responsibility (SA8000)\***.

We are developing operating spaces suitable for the staff, which will be ideal welcoming for the reception of the Customers some employees take care of the reception of customers and perfect spaces for carrying out technical tests studies and product researches and anything needed for the development of the Company. The results of the audits, our Customer satisfaction surveys, the quality of the products and services are the subject of analyses and continuous improvement.

In addition, even during regular work in the Company, both through internal audits and risk analyses/opportunities and during regular control activities, we involve the Staff to further raise their awareness on the objective of **Quality**. The satisfaction of our Customers, the serene collaboration of human resources, the operational seriousness and the image of our Company and last but not least profit, are the fundamental principles that push us to operate with constant commitment and personal satisfaction.
